Day Two

Today is the day of the Happy Times Tours Roaring 20's Speakeasy. Get ready for an evening of food, fun and LOTS OF PRIZES! It's going to be the bees knees! We don't want this important information falling into the wrong hands (those coppers trying to stop our fun). The dinner will be a plated dinner and you must choose at time of reservation if you would like the BBQ Ribs or the 1/2 Baked Herb Chicken. You do not have to dress up in Roaring 20's attire, but our Happy Times Team will be. (Please remember to wear your mask at all times while not eating or drinking)



Day Three

- 11:00am** All passengers must be checked out of their rooms and luggage in the Group Lounge on the rack posted HAPPY TIMES TOURS. The driver will take it from there and load it on the coach. Promo Cash will be added on players card approximately at 7:00am good towards slots only. All Promo Cash MUST be used before departure.
- 3:00pm** Depart the Island Resort & Casino
—All passengers can turn their watches back an hour because we return to *Central Time zone*—turn watches back 1 hour on our way to Wisconsin.
A break/dinner stop will be made enroute. Location will be at the tour director and driver discretion.
- 7:00pm** Estimated return to Hwy 83 Park & Ride in Delafield
- 7:30pm** Estimated return to Johnson Creek Park & Ride
- 8:00pm** Estimated return to JCPenney East Towne Mall in Madison

NOTE: Arrival time at the Island Resort & Casino on Day one is Michigan time (Eastern Standard Time) which is 1 hour ahead of Wisconsin time (Central Standard Time). Wake up call time, checkout time and departure from Island Resort & Casino times on Day Three are also in Eastern Standard Time. Please ask your Happy Times Tour Director if you have questions or concerns on the time.

IMPORTANT REMINDER: Please use your players card at all times while gaming at casinos.

Cash-Out Casino Special Event Policies: Advanced reservations are required since we limit the number of passengers to ensure we can safely distance all travelers on the motorcoach. Book early as there will be limited availability. We require full payment 35 days prior to departure on special event trips. You can prepay with Visa, Mastercard, or check (if you pay with Visa or Mastercard a non-refundable 3% fee will be charged). Cancellations are accepted up to 14 full business days before the trip departs. For any cancellations within 14 full business days of departure, a \$50 per person cancellation fee will apply in addition to any non-refundable costs incurred by Happy Times Tours & Experiences. Business days are defined as Monday through Friday and do not include legal holidays. Please leave a message if it is outside of business hours.

RESERVATION REQUIREMENTS: All reservations require a passengers full legal name as it appears on their drivers license, street address, contact phone number, date of birth and player card numbers (if applicable).

IF YOU ARE SICK STAY HOME! Please call the Happy Times Tours & Experiences office and let us know you are sick (or leave a message if it is after hours). We will attempt to get as much money back as we can from vendors to refund back to you in the form of a travel voucher that you can use on another trip, but there are no guarantees. However, in the best interest of everyone, if you are sick to stay home and get healthy.

NOTE: All Casinos require patrons to have a valid photo I.D. to receive specials and collect jackpots. For winnings over \$1,199, casinos will require a Social Security Card also to collect your winnings. All times are estimated and subject to change. Casinos reserve the right to change or modify all casino rebates, offers, and meal packages without notice. Gratuities for the driver and tour director are **not** included in the price of the tour. Please note that due to COVID, destinations may close or not accept groups.
