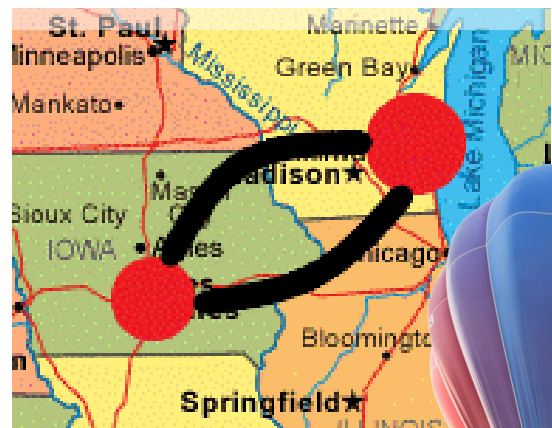

Sunday, July 28 - This morning we board our motorcoach and begin our journey into Iowa. Along the way, we will get to know our fellow travelers. We will make a stop at the **Matchstick Marvels Museum**, home to some of the most spectacular matchstick models in the world! Using millions of matchsticks and gallons of glue, Pat Acton creates models that are highly detailed and painstakingly scaled. Tonight we arrive to our hotel and enjoy a light dinner and cocktails. **(LS)**

Monday, July 29 - After breakfast, we are off to **Madison County**. As we venture through this unique and colorful county, we will learn about its history and the place that inspired ***The Bridges of Madison County***, one of the greatest love stories of our time. While we won't have time to visit them all, we will get to see some of the famous covered bridges that have put this county on the map. There's the **Roseman Bridge**, which was featured in the novel and movie. The **Cedar Covered Bridge** is pictured on the cover of the original novel. The **Holliswell Bridge** is the longest bridge at 122 feet and is featured in the movie. Three other bridges, Cutler-Donahoe, Hogback, and Imes are famous in their own right. Perhaps even more famous than the bridges, is the **Birthplace of John Wayne**. This four room house is now a museum and dedicated to the life and career of this iconic American star. After enjoying lunch, we will make a visit to the **Iowa Quilt Museum** which showcases the beautiful art and culture surrounding quilting. The Iowa Quilt Museum is an aesthetically beautiful and culturally valuable institution, not just for Madison County or quilting enthusiasts, but to all lovers of the arts and American heritage. After a day filled with excitement, we will return to our hotel to catch our breath before heading back to the balloon launch for their evening flight and entertainment. Tuesday, July 30 - Rise and Shine! This morning you will have the option to attend the **Morning Competition Flights**. Watch as balloon pilots "race" to win points based on accuracy and skill. Perhaps you will even decide to take a balloon ride yourself (**OPTIONAL: \$260 Per Person**). We will make our way through the **National Balloon Museum & Ballooning Hall of Fame**. This colorful museum is dedicated to all things hot air balloon! The museum dedicates itself to providing the public with a comprehensive understanding of ballooning and its history through exhibitions and collections. This national museum made its home in Indianola because the city is known for its prime flying conditions. For many years, this area was home to the Balloon Federation of America's National Championships. Lunch will be included this afternoon before we take some time to enjoy some wine at **Sunset Winery** along with a tour of this beautiful property. Another night of beautiful balloons and wonderful entertainment fills the air this evening. Balloons suspended over the horizon, skilled pilots from around the world, roaring burners creating a whoosh that is both heard and felt - all of this and so much more! **(B,L) Balloon ride accommodates 14 people.
